

HORSE SCHEDULE RULES

RULES & REGULATIONS.competitrors are requested to read these regulations carefully.

ENTRY FEES: 1. Entry to all horse events will be by ticket only. You will purchase tickets to the value of the entry fee from Show Office and hand completed to Steward in the ring you are entering.

2. Entry Fees may be refunded only in special circumstances, and you must see the Treasurer to gain refund. PAYMENT OF PRIZE MONEY:

3. Supremes/Champions/Championship classes will receive their money at the Show Office after the GRAND PARADE on Thursday. You will receive a card in parade to present for collection of p/money.

4. Please ensure you have your Prize Money Voucher & Grand Parade card to collect Prize Money for Supremes/Championship.

5. Any Supreme Champion/Champion/hampionship not appearing in the Grand Parade will forfeit that prize money.

6. All other prize money will be paid from Ring Office daily.

7. Prize money not collected by Sat, 2pm 1st June 2024 will be forfeited and returned to the Society's funds. All prize money and entry fees include GST which is payable by all competitors whether registered or not for GST purposes.

DISPUTES:

8. If a dispute arises as to the age of a competitor, the only proof of age accepted will be a birth certificate.

9. No dispute to be considered whilst the event is in progress. Protests are to be lodged in writing after the event has been completed and must be handed to the Show Office, accompanied by a fee of \$50 within 30 minutes of completion of the event. Dispute Committee decision will be final.

GENERAL:

AL: 10. The show is conducted under the rules and regulations of Bundaberg A.P. & I. Society Inc.

And Qld Agricultural Societies & E.A where specified.

11. Measuring Steward is available if required.

12. All STALLIONS/COLTS, two years & over must be led in a bit. The handler/rider must

Have attained the age of 18 years on the day of the show.

 All entries must be registered with the applicable Breed or Registered Societies or recorded in accordance with the rules of the respective breed society. Registration papers are required. NO REGISTRATION, NO ENTRY.
 Competitors must wear CORRECT ATTIRE. Approved riding helmets AS/NZ/3838 2006 onwards. ARB HS 2012 provided they are SAI Global marked and riding boots essential. Jeans and T Shirts/transparent clothing are

not considered suitable attire. 15. No ring shall be required to wait for any competitor who may be competing in another ring. However, WE

WILL ENDEAVOUR TO ASSIST ALL COMPETITORS WHERE POSSIBLE.

16. An Exhibitor shall ensure that horses and competitors are entered and shown only in the correct class.

17. If in the opinion of the Judge, any horse or pony is entered in the wrong class, the Judge shall have the power to classify it in the correct class.

18. The age of a horse shall be calculated from 1st August in the year it is foaled.

19. Stewards reserve the right to alter any event in the schedule.

20. Stewards reserve the right to refuse any entry without reason.

21. A Judge/Steward may direct any person or horse from the competition for bad conduct or one or both.

22. The Committee reserves the right to swab any horse and swabbing may be done during Championship Events. Offenders will be banned.

23. An exhibit is ineligible to compete if the competitor/exhibitor is a member of the judge's family, if the horse has been owned or leased by the Judge or a member of his/her family within the last 3 months, if the competitor has received tuition from the judge within the last 3 months.

24. A Judge shall not visit the horse stables, nor the owners, nor inspect or discuss any horse entered in the show prior to or during the judging of the relevant section.

25. HORSE HEALTH DECLARATIONS for bio security reasons must be completed and handed in at the Show Office upon arrival at the Precinct. Forms are available at Show Office or Show Society website. www.bundabergshow.com.au

26. All electrical equipment and leads must be tested and tagged to comply with safety regulations.

27. NO OPEN FIRES. TOTAL FIRE BAN ON SHOWGROUND

LEDS:

HACKS:

- 28. All led classes will be completed before Ridden classes judged.
- 29. All first-place winners in Gelding classes are eligible for Supreme Gelding of Show.
- 30. Supreme led shall be judged after all Led classes are completed.
- 31. Competitors are advised that riders in Hack, Galloway and Pony classes can only ride one horse in each event. Except where competitors have more than one entry for the Championship.
- 32. District events are restricted to owners/riders residing within the BRC for a period of 6 months. With respect to Lease, lessee shall be deemed to be owner if lessee has been in possession of lease for 6 months prior to first day of show.
- 33.A Novice is a horse or pony that has never won a Championship in a similar contest at an Agricultural Show.
- 34. Pony n/e 14hh, Galloway over 14hh n/e 15hh, Horse over 15hh.
- 35. Horses may be entered in Hack Classes or Hunter Hack Classes, but not in both. Open Hacks may not compete in Show Hunter Classes.
- 36 Stallions are not permitted in Hack/Show Hunter Classes.
- 37. Stallions are ineligible.
- 38. Show Hunters have more substance than the modern fine Hack/Pony but still maintain quality.
- 39. They are expected to move freely.
- 40. They may at any time be expected to gallop for the Judge.
- 41. The Turnout for Show Hunters is more subdued than that of the usual saddle classes.
- 42. There should be no colored browbands on Show Hunters, or Multicolored hair ribbons or flowers on the child rider.
- 43. Junior Riders should not wear boots. Tweed coats are optional.
- 44. Show Hunters cannot compete in any Novice or Open Hack Classes.
- 45. All show jumping events unless otherwise stated will be conducted under EFA rules.
- 46. A Junior Rider may compete in both junior and open competition provided they are members of EFA. a. Junior – EFA rules
 - b. Young Riders QLD EFA rules
- 47. All riders/competitors must compete in correct dress, i.e., shirt, tie, jodhpurs, coat, approved riding helmet And boots. T Shirts and open neck shirts are not permitted.
- 48. Should entries be excessive; the jumping steward reserves the right to limit competitors to a set number of Horses in each event. The number of horses will be determined by the final number of entries.
- 49. A draw will be conducted before each event and the draw will be displayed at the Judges Box. Horses must Where practicable jump in order of the draw.
- 50. All show jumping classes will be by EFA rules, unless otherwise stated. E.g., District, Childrens Show Jump class etc.
- DOGS: Dogs come on Showgrounds/Precinct as the OWNERS RESPONSIBILITIES and must be securely chained Inside vehicles or if under on a short lead so that they cannot dive out and bite anyone. Pleas clean up after your Dog daily. NO LOOSE DOGS ON GROUNDS.

CAMPING & STABLES:

All Camping sites will be allocated. We have a very limited camping area. We endeavor to place you as close as possible to you Horses. The size of your vehicles will determine where your allocated site will be. If you park in someone else's site, YOU WILL BE MOVED or may be asked to exit the show.

All Stables will be allocated. There are also limited numbers of stables. Travelling horses will get first preference. If you have a special request, please contact Stable Steward. All stables MUST BE CLEANED DAILY & WHEN LEAVING. All manure and all hay/feed (that includes loose stringy bits as well) must be removed from stable.

The Bundaberg Show Society requests each Horse Exhibitor to at least enter 1 horse in the Grand Parade on Thursday. Supreme Champions/Champions must parade to be eligible to collect that events money.
